# 4. Matters Arising

# Allotments Committee

Alan Brudney told Council that, after the discussion which took place at the December Council, a meeting of the Allotments Committee will be held on 8<sup>th</sup> February with the site managers.

### **Bute Mews**

Barbara Bliss reported that the vandalised fence had been repaired and the fly tipping situation has improved. However, there are still outstanding issues: the decking from the closed restaurant in Kingsley Way is an eyesore; the low entrance arch to the Mews from Kingsley Way was hit by a lorry, (thought to be from Barnet or a Barnet contractor) which brought down some masonry; the closed supermarket is

being used for cooking food. Barbara Bliss thought that the owner of Kay's delicatessen in Golders Green also owns the supermarket.

It was suggested that the landlord of the flats should be informed by the tenants and asked to ensure that the structure of the building has not been weakened. The tenants would like a sign erected to indicate the height of the arch.

David Lewis suggested that Barbara Bliss asks the tenants of the flats to talk to the managing agents. If they have no success Barbara Bliss should write to him or Gary Shaw, with a copy to Council, supplying details and history of the property which could act as a draft for a letter of complaint from the RA to Barnet, probably sent via Suburb Clirs. **BB** 

## Finance and Proms at St Jude's

David Lewis had suggested removing one-off items from the RA Budget and enable grants to be decided on an ad hoc basis. Peter McCluskie said that if an item is in the budget it does not mean that the RA has authorised this expenditure and Louise Hillman drew Council's attention to the narrative in the management accounts which cover this point.

Jeremy Hershkorn thought the grant should remain in the RA's budget Ian Tutton said that there had been an assumption by the Proms Committee that they will receive the grant from the RA but the RA may not be able to continue to cntinue the grant in the future.

David Lewis said that the RA is lacking revenue and relies on a declining number of members and may have to lower the grant in future years. It would not be appropriate to draw on reserves to make the grant. Louise Hillman thought that we should not discuss the grant until the paper have been circulated but she did not think that the St Jude's Proms Committee take the RA's contribution for granted. David Littaur said that it is perverse to assume that the Proms are making such presumptions. David Lewis said that the RA does not raise money to give away to charity. This will be discussed further iat the February Council meeting.

#### Finance

Louise Hillman had circulated the management accounts in advance and she said that there had been no significant changes. She awaits the final figures for the New Year's Eve fireworks and information from Tony Ghilchik regarding LB Barnet's tree planting. **Dlt/TG**

# 7. Committee Reports

### Membership and Marketing Committee

lan Tutton circulated a paper setting out his views on how Suburb organisations and businesses could become associated with the RA. The aim was to create an income stream which could become a special fund and how this could be structured without becoming a new category of membership nor involving a change to the constitution He suggested a donation of £50 pa and the establishment of a liaison committee

David Lewis proposed and Peter McCluskie seconded a Motion

That the proposed new association of organisations and businesses referred to in the paper prepared by ian Tutton should be called 'Friends of the HGS Residents Association'

This was passed with 11 votes in favour, 1 against and 1 abstention. Council members were in favour of this suggestion and Jeremy Hershkorn proposed that any advertiser or sponsor should automatically become a 'Friend'

David Lewis proposed and Gary Shaw seconded a Motion: That Ian Tutton should be appointed to the Marketing and Membership committee

This was passed unanimously, Ian Tutton agreed to progress this initiative through the Marketing and Membership Committee and he resigned from the Events Committee.

## RA Nominee for HGS Heritage Committee

Jonathan Seres had agreed to be the RA's nominee until 30 April 2017 and he had agreed to continue for a further twelve months.

David Lewis proposed and Tony Brand seconded a Motion: That Jonathan Seres be nominated as the RA's nominee on the HGS Heritage Committee for a further period of twelve months from 30<sup>th</sup> April 2017.

This was passed unanimously

### The Orchard Housing Society
